A previously drafted Faculty Senate Statement was presented and subsequently collectively edited to read, "NJIT is a university that embraces diversity and sees that diversity as a source of strength. The NJIT Faculty Senate finds specific racist pronouncements made by University Lecturer Jason Reza Jorjani in these articles and documents about race and biology to be morally repugnant. Hate and bigotry have no place on the NJIT campus." G. Thomas motion to accept statement. E. Michalopoulou seconded. Motion was approved. (18 yes, 0 no, 1 abstention)
