### **Assessment Grants**

Provides funds to carry out brownfield assessment activities at eligible sites including:

- Site inventory
- Prioritizing sites
- Phase I & II assessments
- Community outreach & involvement
- Cleanup planning (Analysis of Brownfield Cleanup Alternatives (ABCA))
- Site reuse planning\*

## Cleanup Grants

- Provide funds to carry out brownfield cleanup activities at property(ies)
- An individual applicant can apply for up to 5,000,000 for one site\* or multi-site cleanups
- Period of performance is 4 years.
- No cost share with BIL, historically there was but with BIL cost chare has been taken away.
- ► The applicant must be the sole owner of the subject property by the proposal due date.

## Revolving Loan Fund Grant

- Provides funds to capitalize a revolving fund and to make loans and subgrants to carry out cleanup activities at brownfield sites.
- Eligible use of funds includes:
  - Loans or subgrants for cleanups.
  - Preparing and updating ABCAs
  - Developing a Quality Assurance Project Plan (QAPP)
  - Limited site characterization to confirm effectiveness of proposed cleanup design once action has been completed.
- Period of performance is 5 to 15 years.

# **Multipurpose Grants**

- Provide funds to carry out brownfield assessment <u>and</u> cleanup activities at eligible sites including:
  - Site inventory
  - Phase I and Phase II assessments
  - Community outreach and involvement
  - Cleanup and Reuse planning
  - Developing an overall plan for revitalization
  - Site cleanup

# Environmental Work Force Development and Job Training Program Grants

- Create a local workforce that supports various aspects of environmental cleanup
  - Can apply for up to \$500,000
  - Period of performance is 5 years.
- Must provide 40-Hour Hazardous Waste Operations and Emergency Response (HAZWOPER) to all trainees.
- Examples of other acceptable training tailored to local job market:
  - Solid waste management or cleanup training
  - Wastewater treatment and/or stormwater management training
  - Emergency response training
  - Enhanced environmental health and safety and/or chemical safety training.



# Targeted Brownfields Assessment (TBA)

- Direct Assistance program (not a grant)
- Simple application form
- ► EPA contractors perform brownfields activities
  - Phase I ESA (due diligence)
  - Phase II ESA
  - Development of ABCA
    - Cleanup options and cleanup cost estimates
- Applicant need not own the site, but must obtain property access


